Antonio's experience with international trade rules and global supply chain strategies is honed through years of work advising clients across all sectors, and as a former US Customs and Border Protection (CBP) attorney in Washington. He works with companies ranging from small producers to large multinationals in various sectors, helping their company executives ask the right questions and build the right answers. Through his industry lead roles, he counsels numerous clients engaged in the development, manufacturing, and distribution of electric vehicles (EVs), from critical minerals and battery components to the finished vehicle and charging station infrastructure, among other clean technologies.

Antonio advises US and foreign manufacturers, importers, and exporters on various international trade matters affecting their production and supply chains.
